Business Partnerships Research Guide

Overview

This research guide includes information and resources on business partnerships. Included subjects are limited partnerships and limited liability partnerships. A limited-liability partnership is when a "partner is not liable for a negligent act committed by another partner or by an employee not under the partner's supervision." (Black's Law Dictionary, 11th ed.) In a limited partnership, "one or more persons who control the business and are personally liable for the partnership's debts (called *general partners*), and one or more persons who contribute capital and share profits but who cannot manage the business and are liable only for the amount of their contribution (called limited partners). (Black's Law Dictionary, 12th ed.) The resources listed below are not exhaustive and may not include the most up-to-date information.
