### **Overview**

Sometimes referred to as "traffic court," municipal court is a court with "jurisdiction (usually civil and criminal) over cases arising within the municipality in which it sits." (Black's Law Dictionary, 11th ed.) Examples of types of cases that can be heard in a municipal court include dangerous dog hearings, code enforcement hearings, and zoning violations.
