Weekly Arbovirus Surveillance Report: MMWR Week Oct 13-Oct 19, 2024



Week 42 Summary

- 169 mosquito pools* have been tested in NTRL from week 42
 - Year-to-date NTRL has tested a total of 4850 mosquito pools
- 7 mosquito pools tested positive for WNV this week:
Arlington (1) Fort Worth* (2) Keller (3) North Richland Hills (1)
- There have been 0 imported human cases of SLE or Zika in 2024. There have been 5 cases of Dengue Fever. There have been 70 human cases of West Nile disease.
- Average number of mosquitoes/trap include:
 - *Culex spp*: 52.3
 - *Aedes aegypti* and 3.9
 - *Aedes albopictus*:

Figure 1. Average Number of Female *Culex* Species Per Trap and Vector Index by Collection Date, Tarrant County, 2023-2024

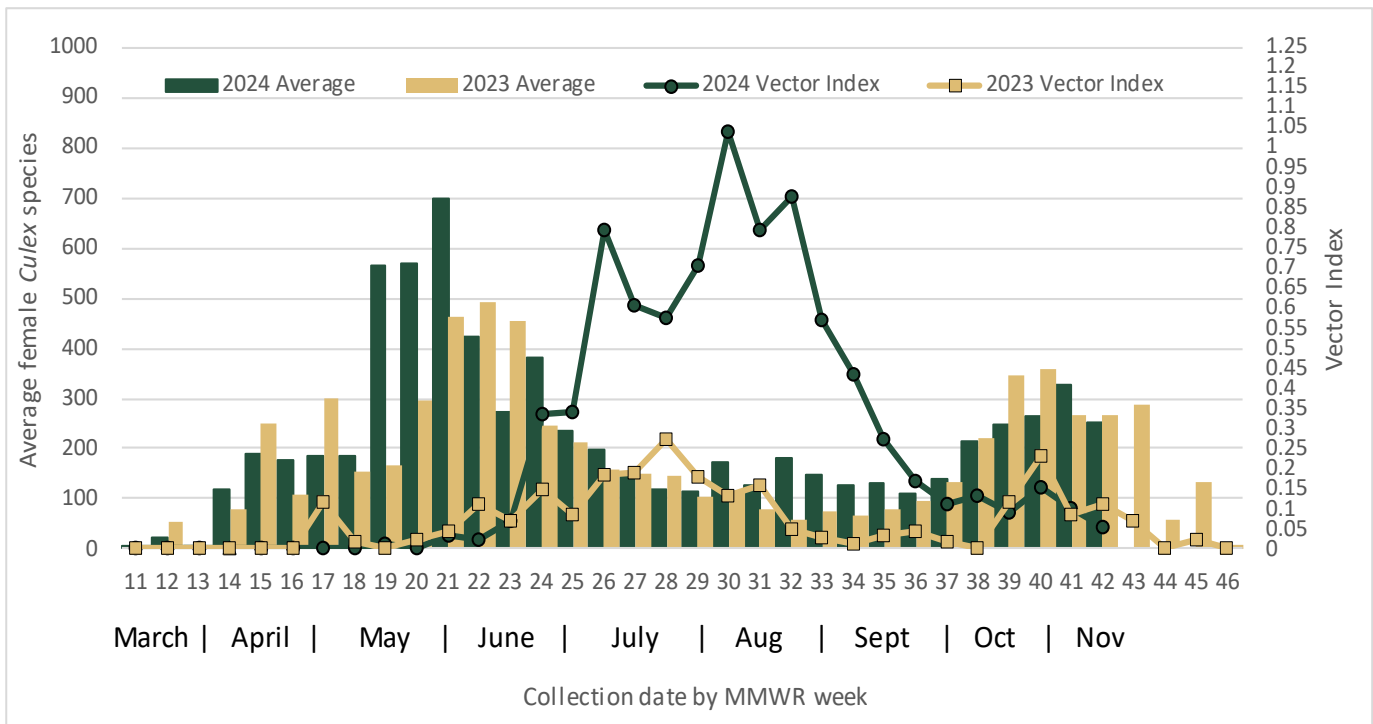
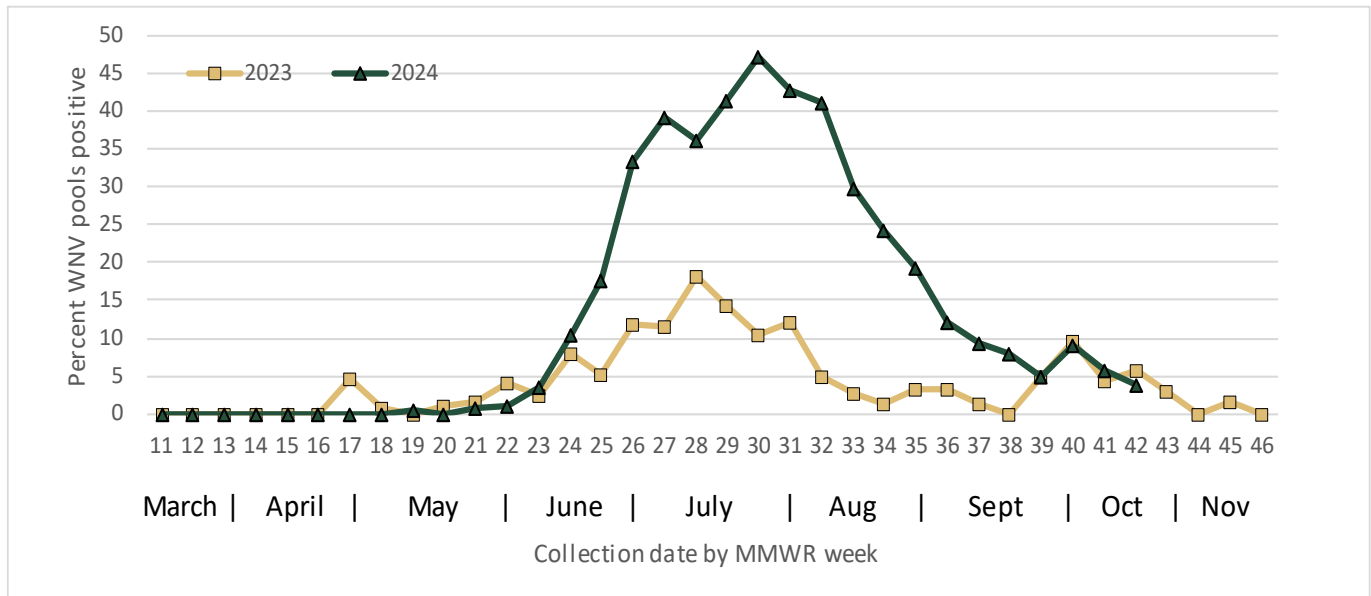


Figure 2. Percentage of Mosquito Pools Positive for WNV by Collection Date, Tarrant County, 2023-2024
